- Each party shall maintain confidentiality regarding any information received from the other party. The publication of any jointly developed material will be considered confidential and shall not be shared in any public forum or with any third party without prior consent.
- This memorandum shall remain in effect for an unlimited period from the date of its execution by both parties. Either party may terminate this Memorandum of Understanding by providing seven days' written notice to the other party.
- The terms of cooperation may be extended beyond those specified in this Memorandum of Understanding, subject to discussion and mutual agreement between the two parties.
